Here's to our next 10 years!



INTRODUCING THE SAN DIEGO CYBER CLINIC

CCOE, CSUSM, National University, and SDSU launched the **San Diego Cyber Clinic** with a \$1M grant from **Google's Cybersecurity Clinics Fund** and support from **The Consortium of Cybersecurity Clinics**. The Clinic is training students to provide free digital security services to under-resourced organizations, similar to how law or medical schools offer free community clinics. The only multi-university and nonprofit-led clinic in the Consortium, the San Diego Cyber Clinic aims to grow an inclusive cyber workforce, increase digital security for all, and serve as a model for regional collaboratives to help establish a clinic in every state by 2030.









"The San Diego region is leading the cybersecurity charge with more than 1,000 firms, top ranked education and research institutes, and NAVWAR. This collaborative 'Ecosystem in Action,' as highlighted in the White House National Cyber Workforce and Education Strategy, is helping seed and diversify the talent pipeline, which is critical to advancing our country's homeland security."



The City of San Diego's Regional Cyber

Lab and CCOE released My eCISO, a
conversational AI chat bot that provides free
custom cybersecurity evaluations and report
cards based on the NIST framework to help
public and private organizations bolster their
cybersecurity. Developed in partnership
with San Diego's cyber community, Cal Poly



SLO's Digital Transformation Hub, Amazon Web Services, and 11:59, My eCISO is the latest addition to the Lab's offerings to provide the region with coordinated cybersecurity through access to tools, intelligence, and training. The Lab and My eCISO were featured at AWS Imagine, GovAl Coalition Summit, and GovTech's Digital Government Summit for pioneering new innovations to serve the community and build resilience and digital equity.

San Diego ranks #1 for their citizen-centric focus with implementation of digital, emerging, and AI technologies to improve city services and citizens' digital experience, including release of an artificial intelligence chatbot called My eCISO to help small businesses and agencies improve their cybersecurity programs."

GROWING AN INCLUSIVE CYBER WORKFORCE



As the cybersecurity talent gap continues to grow—to the tune of 457,000 job openings in the U.S. and 5,500 here in San Diego—CCOE, EDC, and San Diego Workforce Partnership are seeding and diversifying the regional pipeline with **CyberHire**, a program helping underrepresented San Diegans join the field. To date, CyberHire boasts 204 student enrollments (exceeding the 185 target!), 42 participating employers, 5 academic providers, 123 certifications, and 69 employments! We are excited the program has received continued funding through the California Breaking Barriers and NIST RAMPs grants and now includes CCOE-supported Able-Disabled Advocacy's **CAREERworks** and **NFAR Cyber**, a cybersecurity

We also added new employer features to the **Cyber Career Map** with Journeys Map and worked with local school districts and nonprofits

CCOE continues to expand the new Member Marketplace, where members can both provide and access discounted cybersecurity-related products, services, and support. In tandem, the CCOE Cyber SMB Advisory Group and Affiliate Membership is growing to support the region's small to medium-sized cybersecurity companies. We are also fostering partnerships with government and academic innovation centers, VCs, and regional nonprofits to bring new technologies and solutions to market and connect cyber SMBs to established programs and resources.

RAISING CYBERSECURITY AWARENESS AND RESILIENCY

The global cost of a data breach has surged to over \$4.88 million according to IBM, and the FBI reports more than 150% increase in cybercrime complaints across all industries in the last 5 years. Alarmingly, more than half of these costly attacks are aimed at small and medium-sized businesses, our region's economic engine. To help educate our business community on cyber threats, mitigation strategies, and available resources, CCOE hosted a quarterly Cybersecurity Workshop Series with the **City of Carlsbad** and the **Carlsbad Chamber of Commerce** and a 5-part Webinar and Podcast Series with the **City of San Diego**. The programs featured FBI insights, CISO lessons learned, incident response planning, and best practices in cyber insurance, legal, finance, and communications.

CCOE is also celebrating the seventh year of the **FBI Executive Briefing Series** to support the bureau's industry engagement efforts and educate San Diego's key sectors on cybersecurity risks and solutions. This year, we expanded the series to include additional government and industry experts with briefings for the Defense, Cleantech, Legal, Maritime, Education, and Infrastructure sectors in partnership with NDIA, SDMAC, Aerospace & Defense Forum, U.S. Marine Corps, Cleantech San Diego, San Diego County Bar Association, Port of San Diego, San Diego Working Waterfront, TMA BlueTech, U.S. Coast Guard, Navy Gold Coast, and the San Diego Regional Cyber Lab. Since inception, we have hosted 44 briefings reaching more than 2,800 executives from small businesses to global corporations and helped expand the program to Orange County, Inland Empire, Los Angeles and Hawaii.





CHAMPIONING THOUGHT LEADERSHIP & RESOURCES

With the help of KCD PR, CCOE secured 35 articles totaling over 110M impressions (including multiple covers!) highlighting the region's cyber ecosystem and increased our digital community by 20% to connect on industry news and events, best practices, and career and business opportunities. CCOE once again partnered with the **San Diego Business Journal** on a series of quarterly Cybersecurity Panels & Special Reports and

hosted the fourth annual Cybersecurity Stewardship Awards.

featured the series **Cybersecurity is Everyone's Business** to share lessons from the trenches of our region's key sectors—including Retail, DIB, Water, Medical Devices, Research Institutes, and more—that can be applied to all businesses.
